Section 2 TERMS & CONDITIONS OF TRADE

2.1 The Applicant acknowledges receipt of and agrees to observe Medcan Group Pty Ltd's Terms & Conditions of Trade in respect of all goods and services supplied by Medcan Group Pty Ltd from time to time.

2.2 If Medcan Group Pty Ltd grants this credit facility to the Applicant, all accounts must be paid in full within 14 days of date of invoice unless Medcan Group Pty Ltd agrees otherwise in writing.

2.3 Any expenses incurred by Medcan Group Pty Ltd in recovering or attempting to recover any outstanding amount from the Applicant or otherwise including any fees payable to any agency or any debt collection agency and legal costs will be paid on a full indemnity basis by the Applicant.

2.4 Interest at current bank overdraft rates may be charged on any overdue amount on the account and further, in consideration of any grant of credit, the Applicant expressly undertakes to pay all such interest.

2.5 Medcan Group Pty Ltd may at any time terminate any credit arrangement with the Applicant. In this event, all monies owing by the Applicant to Medcan Group Pty Ltd will become immediately due and payable.
